Library services. Our librarians service our patrons' needs for books, DVDs, magazines, games, and interlibrary loans, as well as fax, scanner, and copier services, and 7 computers for public use. 3,571 patron visits were served during the fiscal year.

Children and youth programs. This included: (a) summer reading program; (b) after school program [learning activities for elementary students after school]; (c) toddler literacy, introducing toddlers to reading at an early age; (d) STEM-to-read; (e) Farm Trip; (f) Wildlife Center raptors education; (g) field trip to artist Nicholas Herrera's studio; (h) adobe brickmaking class; (i) Explora! Science Center traveling exhibit. 280 children, toddlers, tweens, and teens, as well as parents and guardians, attended these programs. We also participated in the Abiquiu Back to School Block Party, providing school supplies for the new school year.

Events. These events were attended by 501 adults, teens, and children. We also participated in the Abiquiu Farmer's Market, providing books and educational materials to 27 attendees.
